**RE: Sacramento County Jail Diversion Treatment and Resource Center**

---

The Jail Diversion Treatment and Resource Center (JDTRC) is a comprehensive Sacramento County jail diversion and resource center for Misdemeanor Mental Health Diversion Court participants 18 years and older who are living with mental illness and/or co-occurring substance use disorder, and/or suffering from trauma.

Most importantly, the project will divert individuals from jails and prisons and provide mental health treatment, substance use disorder treatment, and trauma centered services.

This one-stop center provides easily accessible, community-based, individualized support services and linkages for adult individuals in a convenient location. Participants, including those recently released from custody, may receive a myriad of services including:

- Mental and Substance Use Prevention Treatment evaluations and linkage to services.
- Onsite therapeutic classes.
- Referrals to community-based service providers.
- Contact with a probation officer.
- Onsite meetings with legal representation.

County partners currently participating in the JDTRC program are, Department of Behavioral Health Services, Department of Human Assistance, Office of the Public Defender, Sacramento County Probation Department, and the Sacramento County Superior Court. The JDTRC began providing services on December 13, 2021.

**Background.** The California Board of State and Community Corrections (BSCC) provides services to the county adult and juvenile systems through inspections of county jails and juvenile detention facilities, technical assistance on local issues, promulgation of regulations, training standards for local correctional staff, and the administration of a wide range of public safety, re-entry, violence reduction, and rehabilitative grants to state and local governments and community-based organizations.

**BSCC Corrections Planning and Grant Programs**

The Corrections Planning and Grant Programs (CPGP) Division administers a diverse range of state and federal grant programs to community-based organizations, tribes, and state and local governments. Grant funded services and programs include, but are not limited to, addressing public health and safety, diversion, rental assistance, reentry services, parenting and violence reduction.

Key responsibilities include:

1. Ensure the fair, prudent and efficient distribution of state and federal grant funds.
2. Encourage the use of evidence-based practices to prevent and reduce crime.
3. Engage in collaborative planning, ongoing research and information sharing.
4. Provide grant-related training and other technical assistance.
