## DISASTER PLANNING & TRAINING

DRC can help local government prepare for almost any contingency with confidence. DRC's Director of Technical Assistance and Training, Tony Furr, provides on-going education to DRC's personnel and the jurisdictions we serve. Mr. Furr was the Region VI Debris Subject Matter Expert from 2013 - 2021 for FEMA and is highly knowledgeable about FEMA policies, procedures, and debris operations.

## DEBRIS MANAGEMENT & REMOVAL

Since its inception, DRC has collected more than 156.4 million cubic yards of debris and has established industry benchmark for debris recycling and collection efficiencies. We've executed comprehensive debris operations nationally and internationally, bringing a high level of innovation and professionalism to each and every project. With top-of-the-line equipment and skilled personnel, we provide safe and efficient service to meet all of our clients' needs. From highway traffic control to the use of specialized equipment, we meticulously plan and execute all facets of debris management including right-of-way maintenance. Whether we perform the work ourselves or engage a network of more than 5,000 subcontracting partners, we're able to be on-site quickly, regardless of the size of the event.



## TREE TRIMMING & REMOVAL

DRC has a long standing history of working with our clients to quickly trim, remove, and dispose of hazardous trees and vegetation in the aftermath of disaster events such as Hurricanes Ida, Zeta, Delta, Sally, Laura, Isaias, Hanna, Dorian, Michael, Florence, Maria, Irma, Harvey, Matthew, Isaac, Sandy, Ike, Gustav, Katrina.



## TEMPORARY SITE MANAGEMENT, REDUCTION, RECYCLING & DISPOSAL

DRC has extensive experience locating and managing temporary Debris Management Sites (DMS) in the wake of several major events. During the 2021 Hurricane Season, DRC was activated in 25 jurisdictions, simultaneously managed 82 DMS, and removed/disposed over 16 million cubic yards of debris. Following an event in Southeast Louisiana, DRC operated DMS with such efficiency that FEMA and the USACE filmed the operation to use in training sessions.



## MARINE DEBRIS REMOVAL & RECOVERY

DRC has unsurpassed experience in Marine Debris, Salvage, and Recovery. DRC removed debris from canals, streams, lakes, and rivers in response to Hurricane Laura and has been contracted by the City of Houston to remove vegetative debris from Lake Houston, the San Jacinto River, and surrounding bayous and canals. DRC successfully removed and disposed of over 3.6 million pounds of dead fish over a three-month span in response to a 1-million-acre red tide bloom in the Gulf of Mexico. Additionally, DRC has experience in recovering and recycling vehicles/vessels.



## SAND SCREENING & BEACH RESTORATION

Many jurisdictions are faced with damaged coastal areas and habitats that may require immediate recovery restoration. DRC has performed this sensitive and precise process for decades. A variety of equipment is used to scrape the sand, screen it to remove particles and debris, and redistribute the pure sand along the shoreline to rebuild dunes and contour beaches. DRC has a rich history of sand screening and coastal restoration in responses to disasters such as Hurricanes Ida, Florence, Harvey, Irma, Ivan, and Dennis.



## TEMPORARY HOUSING & LOGISTICS

DRC delivers the rapid, turnkey disaster response services including emergency housing and sheltering, logistical support, and turnkey health services. Our team can begin mobilizing within hours of activation. Our reputation for providing some of the fastest response and construction times in the industry, plus excellent production ratings, have made us a proven leader in disaster response operations.
