Captain Mark Long, Division Commander, Orange County Sheriff's Department Susan Green, Assistant CIO, San Diego County Captain Long will discuss how the Orange County Sheriff's Department is building on the success of their Commendations and Complaints Reporting System to create a Personnel History Index application across the organization. The Personnel History Index tracks data for sworn officers in the following areas: Commendations, Complaints, Uses of Force, Traffic Collisions, Risk Management Claims, Workers Comp Claims, and Internal Affairs Cases. Each of these areas has a defined threshold for occurrences within a period of time to generate an alert and administrative review of the item. The Microsoft system they selected tracks data in each of these areas as well as providing full case management for the Internal Affairs bureau. Data driven workflows will launch the administrative review process and populate dashboards for executive command to review the performance of the officers.

Susan Green will share how San Diego County's juvenile justice agencies have transitioned to a near paperless environment. Like most administrative offices in most county governments throughout the United States, the millions of pieces of paper that were previously created, copied, distributed, filed, and retrieved by hand. To help their employees work more efficiently and effectively, these agencies are replacing that paper with a digital library and workflow management solution based on Microsoft technologies. The result: attorneys glean better insights from their cases while spending less time reviewing them. Within the District Attorney's Office, greater flexibility to assign cases boosts attorney productivity by 14 percent. Support staff productivity is up 50 percent. And the tangible return on investment, across the juvenile justice agencies, is expected to be more than 100 percent.
